

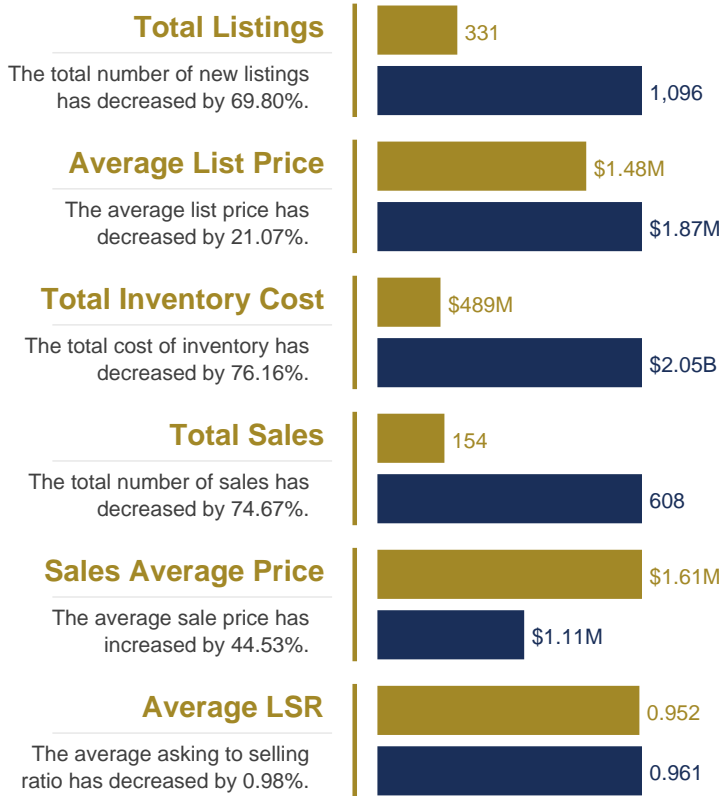

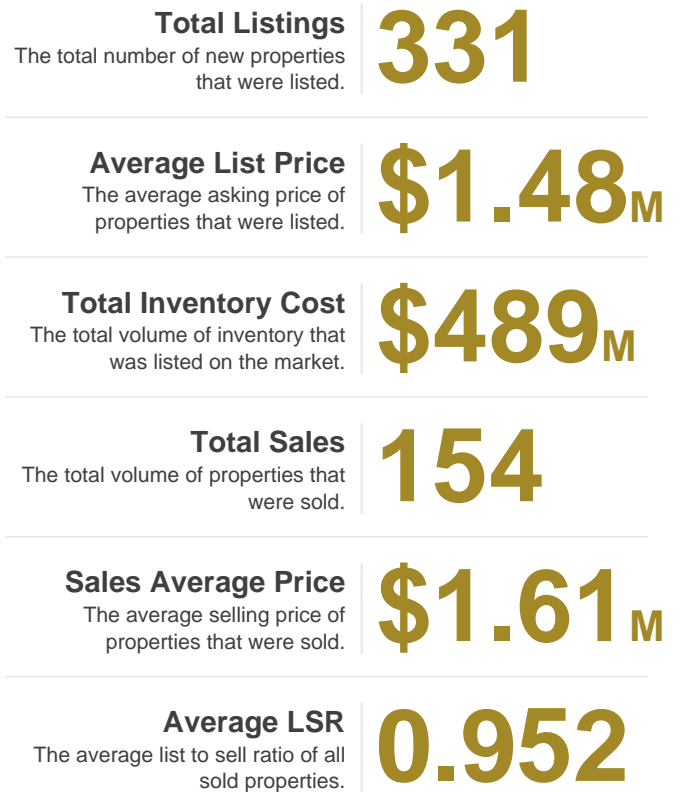
Below, we are comparing the third quarter of 2023 to the third quarter of 2022.

Average DOM

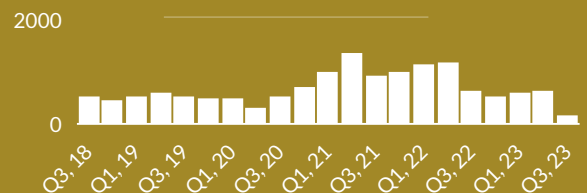

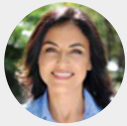
Total Sales Volume

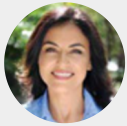

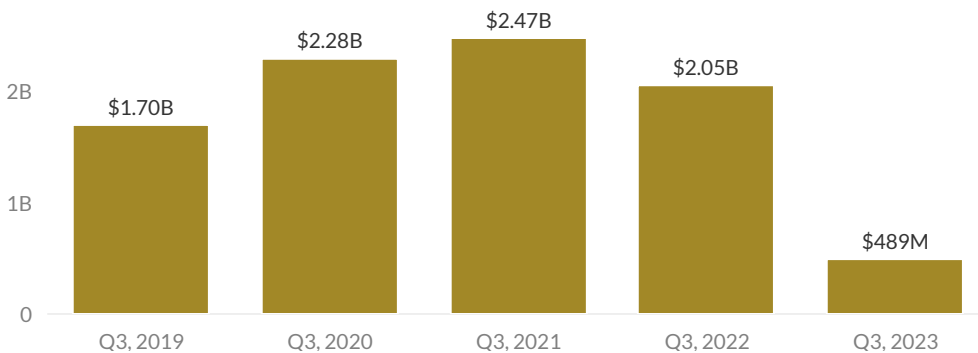

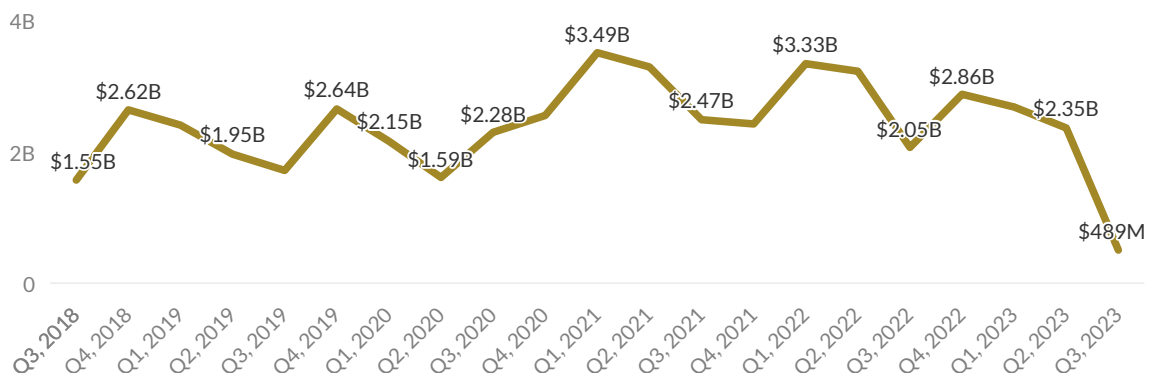

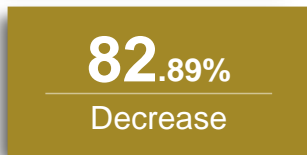

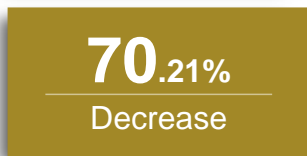

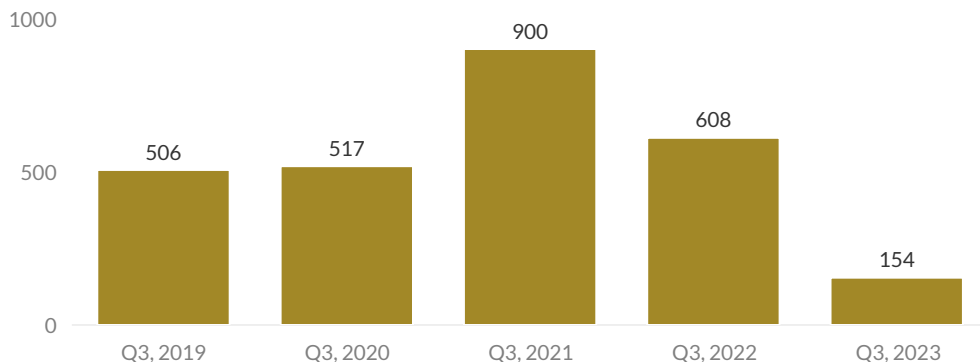

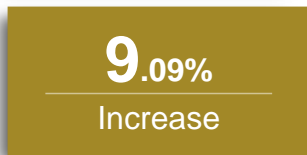
Sales Average Price

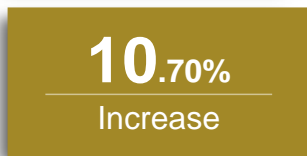

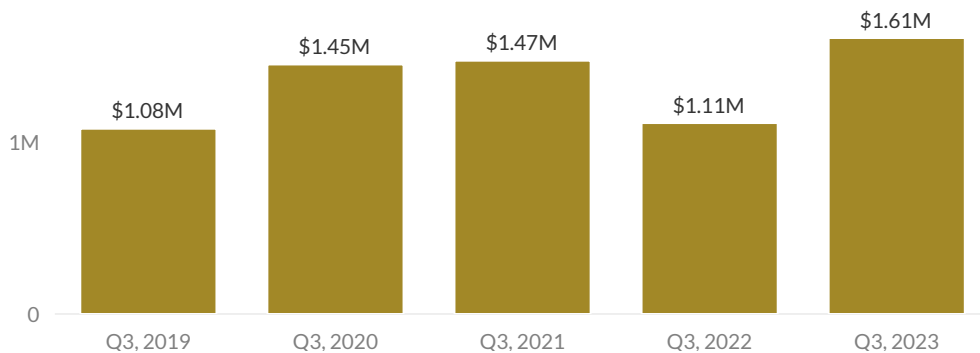

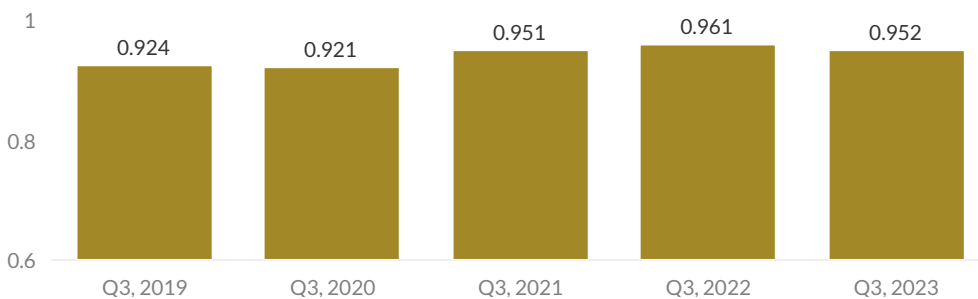

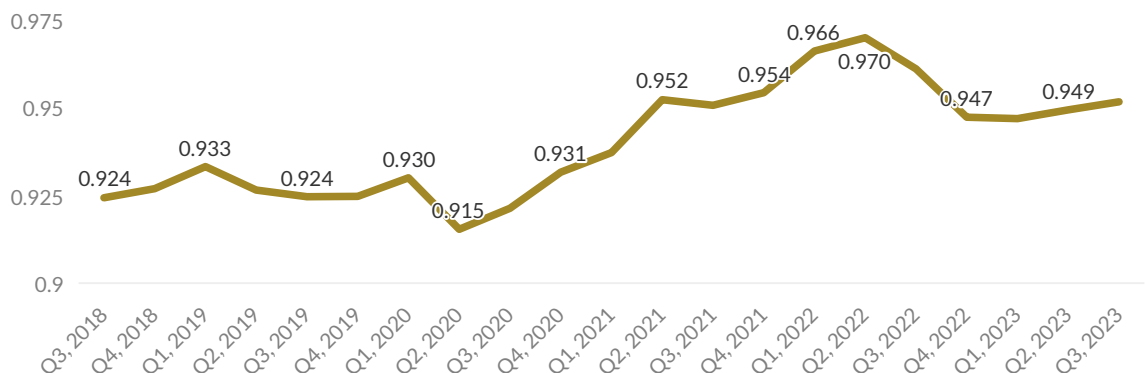
